ANNUAL INVITATION FOR UPCCAA CONSTRUCTION BID LIST

In accordance with CCC 22034 notice is hereby given that Sanger Unified School District invites all contractors to be included on the District's 2019 UPCCAA construction bid list by submitting the following information:

- 1) Contractor name and address where contractor may be contacted
- 2) Telephone number where contractor may be contacted
- 3) Facsimile number where contractor may be contacted
- 4) Type of work (trade) that contractor is interested and currently licensed to perform
- 5) Classification of contractor's license(s) held
- 6) Contractor's license number(s) for each type of work
- 7) Email address of where contractor may be contacted
- 8) DIR Contractor Registration Number (required)

Please note, registering for UPCCAA projects does not meet District Prequalification requirements.

Public works refers to construction, alteration, demolition, installation, or repair work (including maintenance) done under contract and paid by public funds. For a more detailed explanation of public works projects, refer to California Labor Code 1720 -1720.6.

Independent of registering for notification of bid opportunities, contractors wanting to perform on public works project should follow the State requirements below:

- Labor Code 1725.5 requires all contractors and subcontractors intending to bid or perform on a public works project to be registered and annually renew under the DIR Registration Program for prevailing wage compliance. The DIR fee is paid directly to the State by the contractor. The District will not register a contractor, nor collect funds.
- Public Contract Code 20111.6, requires all General Contractors (A and B), Mechanical, Electrical and Plumbing Contractors (C-4, C-7, C-10, C-16, C-20, C-34, C-36, C-38, C-42, C-43, & C-46) to be prequalified by the district in order to be eligible to work on a project totaling in excess of \$1 million dollars. The District's Prequalification Application and current Prequalified List of Contractors may be accessed at the above mention web address under Public Works > Prequalification.


