Qualified applicants will be interviewed by the Board on January 24, 2019.

TRUSTEE AREA 4**

Candidates qualified and interested in being appointed to Trustee Area 4 must to the following:

1. Submit a Letter of Application in the form attached no later than 5:00 p.m. on Friday, January 18, 2019. Note: Late applications will not be considered; however, the Board reserves the right to waive any other irregularities.
2. Letters of Application may be submitted by email to Susan Joneson at the following email address: susan_joneson@sanger.k12.ca.us or faxed to the District at the following number: (559) 875-0311; or personally delivered to Ms. Joneson at the following address: 1905 7th Street, Sanger, CA 93657.
3. Candidates will be screened to ensure applicants meet all requirements of law.
4. Qualified candidates will be interviewed at an open session special meeting of the school board commencing at 7:00 p.m. on Thursday, January 24, 2019.
5. The school Board will select and make an appointment to Trustee Area 4 on January 24, 2019, immediately following candidate interviews.
6. Once a provisional appointment is made, the District will post notices as required by law to allow members of the public to file a petition calling for a special election. If the petition meets all requirements of law, the provisional appointment is vacated and the vacancy will be filled by election in the manner required by law.
7. If no petition calling for a special election is certified, the individual selected as the Board's provisional appointee will serve until the next regularly scheduled board election in November 2020.
